PROCEDURAL HISTORY: On July 18, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 81413). On August 7, 2013, decision # 81413 became final without a request for hearing having been filed. On October 30, 2013, the Department served notice of an administrative decision assessing a \$610 overpayment based on decision # 81413 (decision # 144604). Claimant filed a timely request for hearing. On December 17, 2013, ALJ Lohr conducted a hearing at which the employer did not appear, and on December 19, 2013, issued Hearing Decision 13-UI-06855, affirming decision # 144604. On January 3, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 13-UI-06855 is affirmed.
