EMPLOYMENT APPEALS BOARD DECISION

2014-EAB-0052

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On August 21, 2013, the Oregon Employment Department (the Department) served two notices of a two part administrative decision (#194288). One part of the decision assessed a \$3,964 overpayment and a \$594.60 monetary penalty, and disqualified claimant for 43 weeks of future benefits based on unreported work and earnings. The second part of the decision assessed a \$1,285 overpayment and a \$192.75 monetary penalty based on unreported work and earnings. On August 26, 2013, claimant filed a timely request for a hearing. On October 16, 2013, the Office of Administrative Hearings issued a notice for a hearing on the administrative decision scheduled for October 23, 2013 at 10:45 a.m. On October 23, 2013, ALJ Bear issued Hearing Decisions 13-UI-03159 and 13-UI-03160 that dismissed claimant's request for hearing for failure to appear at the hearing. On November 12, 2013, Hearing Decisions 13-UI-03159 and 13-UI-03160 became final without applications for review having been filed.

On December 13, 2013, claimant filed a late request to reopen the hearing. On January 3, 2014, ALJ Kangas reviewed claimant's request to reopen and issued Hearing Decisions 14-UI-07643 and 14-UI-07644, dismissing claimant's request. On January 3, 2014, claimant filed applications for review of both Hearing Decisions with the Employment Appeals Board.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-07643 and 14-UI-07644. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-14-0052 and 2014-14-0055).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 14-UI-07643 and 14-UI-07644 are affirmed.
