Affirmed Overpayments Afirmado Sobrepagos

PROCEDURAL HISTORY: On September 21, 2010, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report reducing claimant's benefits amount. On April 2, 2010, the Wage and Potential Report became final without a request for hearing having been filed. On September 25, 2013, the Department served two notices of two administrative decisions assessing a \$50 overpayment of Federal Additional Compensation Benefits (FAC) (decision # 134116), and \$298 overpayment of Regular Unemployment Insurance Benefits (UI) (decision # 133932) based on the Wage and Potential Benefit Report. Claimant filed a timely request for hearing. On November 14, 2013, the Office of Administrative Hearings (OAH) issued two notices of a consolidated hearing scheduled for December 2, 2013 at 10:45 a.m. On December 2, 2013, ALJ Lohr conducted an interpreted, consolidated hearing, and on January 3, 2014, issued Hearing Decisions 14-UI-07672 and 14-UI-07681, affirming the Department's decisions. On January 17, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-07672 and 14-UI-07681. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-0133 and 2014-EAB-0134).

EAB considered claimant's written argument to the extent it was relevant and based on the hearing record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 14-UI-07672 and 14-UI-07681 are affirmed.
