EMPLOYMENT APPEALS BOARD DECISION

2014-EAB-0293

Affirmed
Disqualification
Ineligible for EUC Benefits

PROCEDURAL HISTORY: On December 4, 2014, the Oregon Employment Department (the Department) served four notices of four administrative decisions: one concluding claimant voluntarily left work without good cause (decision # 85627); one concluding claimant failed to accept an offer of suitable work without good cause from Quest Staffing Services on August 20, 2013 (decision # 100202); one concluding claimant failed to accept an offer of suitable work without good cause from Quest Staffing Services on September 19, 2013 (decision # 113806); and one concluding claimant was ineligible for Emergency Unemployment Compensation (EUC) benefits because he qualified for other unemployment insurance benefits (decision # 103953). Claimant filed a timely request for hearing. On January 24, 2014, the Office of Administrative Hearings (OAH) issued two notices of two hearings scheduled for February 10, 2014; a consolidated hearing at 8:15 a.m., and one at 9:30 a.m.

On February 10, 2014, ALJ Murdock conducted hearings, and on February 13, 2014 issued Hearing Decisions 14-UI-10319 and 14-UI-10320, affirming decisions # 85627 and #103953, and 14-UI-10323 and 14-UI-10324 concluding claimant did not fail to accept an offer of suitable work from Quest Staffing Services on August 20, 2013 and September 19, 2013. On February 18, 2014, claimant filed applications for review of Hearing Decisions 14-UI-10319 and 14-UI-10320, with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-10319 and 14-UI-10320. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-0293 and 2014-EAB-0294).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 14-UI-10319 and 14-UI-10320 are affirmed.
