PROCEDURAL HISTORY: On January 17, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's backdating request (decision # 134403). Claimant filed a timely request for hearing. On March 26, 2014, ALJ Seideman conducted a hearing, and on March 27, 2014, issued Hearing Decision 14-UI-13539, affirming the Department's decision. On April 15, 2013, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 14-UI-13539 is affirmed.
