

EMPLOYMENT APPEALS BOARD DECISION
2014-EAB-0718

PROCEDURAL HISTORY: On March 3, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was unavailable for work from January 19, 2014 to February 15, 2014 (weeks 4-14 to 7-14) (decision # 91930). On March 17, 2014, the Department served notice of an administrative decision (decision # 194736) assessing a \$1,614 overpayment, \$322.80 in monetary penalties, and 12 penalty weeks based on decision # 91930. Claimant filed a timely request for hearing. On April 9, 2014, the Office of Administrative Hearings (OAH) issued two notices of two hearings scheduled for April 23, 2014; one at 9:30 a.m. and one at 10:45 a.m. On April 23, 2014, ALJ Sime conducted an interpreted hearing, and issued Hearing Decisions 14-UI-15806 and 14-UI-15868, affirming the Department's decisions. On May 1, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-15806 and 14-UI-15868. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-0718 and 2014-EAB-0718).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 14-UI-15806 and 14-UI-15868 are affirmed.
