EMPLOYMENT APPEALS BOARD DECISION 2014-EAB-0763

Affirmed Overpayment Assessed (Se impuso sobrepago)

PROCEDURAL HISTORY: On May 13, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was ineligible for Emergency Unemployment Compensation (EUC) benefits from December 16, 2012 to April 13, 2013 (decision # 71409). Claimant filed a timely request for hearing. On June 4, 2013, the Office of Administrative Hearings (OAH) issued notice of a hearing scheduled for June 13, 2013 at 10:45 a.m. On or around June 5, 2013, claimant withdrew his request for hearing. On June 13, 2013, ALJ Wyatt issued Hearing Decision 13-UIB-09737-D, allowing claimant's request to withdraw his request for hearing. On June 26, 2013, Hearing Decision 13-UIB-09737-D became final without an application for review having been filed.

On March 25, 2014, the Department served notice of an administrative decision (decision # 142321) assessing a \$8,057 overpayment in Emergency Unemployment Compensation (EUC) based on decision # 71409. Claimant filed a timely request for hearing. On April 22, 2014, ALJ Lohuis conducted an interpreted hearing at which claimant appeared and testified, and on April 23, 2014, issued Hearing Decision 14-UI-15838, affirming decision # 142321. On May 5, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). The argument also contained information that was not part of the hearing record, and failed to show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (October 29, 2006). We considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 14-UI-15838 is affirmed. *Decisión de la Audiencia 14-UI-15838 queda confirmada.*
