## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-0801

## Reversed & Remanded

**PROCEDURAL HISTORY:** On February 11, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant but not for misconduct (decision # 115750). The employer filed a timely request for hearing. On April 7, 2014, the Office of Administrative Hearings issued notice of a hearing scheduled for April 18, 2014. On April 18, 2014, ALJ Murdock conducted a hearing in which the claimant did not participate, and issued Hearing Decision 14-UI-15546, concluding that claimant voluntarily left work without good cause. On May 8, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

In her application for review, claimant stated that she failed to appear at the April 18 hearing because she did not receive the hearing notice. Claimant explained that "[a]round the same time the hearing paperwork would have been mailed I was having problems receiving my mail, an incident I wasn't fully was [sic] aware was happening until recently." Claimant further explained that "just this last week I arrived home to find an older gentleman digging through my mailbox." Claimant asserted that problems with her mail have been resolved because her landlord installed a locking mailbox.

Claimant was not afforded a reasonable opportunity for a fair hearing because she failed to receive actual notice of the hearing due to problems with her mail caused by possible theft. *See* OAR 471-040-0015(1) (Notice of Hearing) (August1, 2004). Under the authority granted to us by ORS 657.275(1), we reverse Hearing Decision 14-UI-15546 and remand the matter for a new hearing and a hearing decision.

**DECISION:** Hearing Decision 14-UI-15546 is set aside, and this matter remanded for further proceedings consistent with this order.
