EMPLOYMENT APPEALS BOARD DECISION

2014-EAB-0927

Reversed and Remanded

PROCEDURAL HISTORY: On August 12, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision # 134333). The employer filed a request for hearing on February 4, 2014. On March 4, 2014, ALJ Kangas issued Hearing Decision 14-UI-11628, dismissing the employer's request for hearing as untimely, subject to the employer's "right to renew" the request by submitting a response to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed. On March 11, 2014, the Office of Administrative Hearings (OAH) received the employer's response. On April 15, 2014, OAH issued a notice of hearing scheduled for April 28, 2014. On April 28, 2014, ALJ S. Lee conducted a hearing, and on May 9, 2014 issued Hearing Decision 14-UI-17232, concluding the employer discharged claimant for misconduct. On May 29, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

ORS 657.275 provides that EAB shall review the record of the case and promptly affirm, modify, or set aside the decision of the ALJ if the Director of the Department or any interested party files a timely application for review. On May 29, 2014, EAB notified the Office of Administrative Hearings (OAH) that an application for review had been filed. The record is not yet complete, and it appears that further proceedings are or may be necessary before the record can be provided. We therefore reverse Hearing Decision 14-UI-17232 as unsupported by a complete record, and remand this matter for such other and further proceedings as may be necessary to complete the record.

DECISION: Hearing Decision 14-UI-17232 is set aside, and this matter remanded for further proceedings consistent with this order.
