**EMPLOYMENT APPEALS BOARD DECISION**

**2014-EAB-0949**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On June 11, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily quit work without good cause (decision # 103340). On July 1, 2013, decision # 103340 became final without a request for hearing having been filed. On March 19, 2014, the Department served notice of an administrative decision ( decision # 142855) assessing an overpayment of \$3,900 in regular Unemployment Insurance benefits and \$1,964 in Emergency Unemployment Insurance (EUC) based on decision # 103340. On April 4, 2014, claimant filed a request for hearing on both decisions. On May 13, 2014, ALJ Lohr conducted two hearing and issued Hearing Decisions 14-UI-17506 dismissing claimant's late request for hearing on decision # 103340, and 14-UI-17519 affirming the Department's decision # 142855. On June 2, 2014, claimant filed applications for review of both decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-17506 and 14-UI-17519. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-0949 and 2014-EAB-0950).

Claimant failed to certify that she provided a copy of her argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we did not consider the argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 14-UI-17506 and 14-UI-17519 are affirmed.
