## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-1009

Affirmed
Request for Hearing Withdrawn

**PROCEDURAL HISTORY:** On May 8, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct (decision # 90124). Claimant filed a timely request for hearing. On May 29, 2014, ALJ R. Davis issued Hearing Decision 14-UI-18544, dismissing claimant's request for a hearing on the ground that claimant withdrew her hearing request. On June 10, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

The ALJ's conclusion that claimant withdrew her hearing request is supported by the record, which includes a May 28, 2014 "Memo to File / Telephone Record." This memo, written by an OAH employee, describes a telephone conversation the employee had with claimant in which claimant withdrew her request for a hearing. This document is marked as EAB Exhibit 1; a copy of this exhibit is included with this decision. A party that objects to the admission of EAB Exhibit 1 must submit any such objection to this office in writing, setting forth the basis of the objection, within ten days of the date on which this decision is mailed. Unless such objection is received and sustained EAB Exhibit 1 will remain part of the record.

EAB Exhibit 1 provides sufficient proof of claimant's withdrawal of hearing request. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision is **adopted.** 

**DECISION:** Hearing Decision 14-UI-18544 is affirmed.
