## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-1040

Affirmed
Request to Reopen Denied

**PROCEDURAL HISTORY:** On March 5, 2014, the Oregon Employment Department (the Department) served three notices of three administrative decisions: one concluding claimant was not available for work from December 22, 2013 to February 14, 2014 (weeks 52-13 through 8-14) (decision # 100324); one denying claimant's backdating request (decision # 94926); and one concluding claimant did not actively seek work from December 22, 2013 to February 14, 2014 (weeks 52-13 through 8-14) (decision # 95726). On March 19, 2014, claimant filed three timely requests for hearing.

On March 27, 2014, the Office of Administrative Hearings (OAH) issued three notices of a consolidated hearing scheduled for April 11, 2014 at 10:45 a.m. Claimant did not appear at the hearing. On April 11, 2014, ALJ Sime issued Hearing Decisions 14-UI-15030, 14-UI-15031 and 14-UI-15034 dismissing claimant's requests for hearing for failure to appear. On April 30, 2014, claimant filed a timely request to reopen. On May 23, 2014, ALJ S. Lee reviewed claimant's request to reopen and issued Hearing Decisions 14-UI-18345, 14-UI-18342 and 14-UI-18340 denying claimant's request. On June 12, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-18340, 14-UI-18342 and 14-UI-18345. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2014-EAB-1039, 2014-EAB-1040 and 2014-EAB-1041).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 14-UI-18340, 14-UI-18342 and 14-UI-18345 are affirmed.
