EMPLOYMENT APPEALS BOARD DECISION 2014-EAB-1044

Affirmed Ineligible Overpayment and Penalties

PROCEDURAL HISTORY: On March 28, 2014, the Oregon Employment Department (the Department) served two notices of two administrative decisions concluding claimant was not available for work from July 21, 2013 to August 3, 2014 (decision # 91342) and that she was not available for work from August 11, 2014 to November 2, 2014 (decision # 92926). On April 1, 2014, the Department served notice of an administrative decision assessing a \$1,630 overpayment, \$326 in monetary penalties, and 14 penalty weeks based on administrative decision. On May 19, 2014, ALJ Holmes-Swanson conducted a consolidated hearing, and on May 27, 2014, issued Hearing Decision 14-UI-18421 modifying decision # 91342 to find that claimant was not available for work from July 28, 2014 to August 3, 2014. On June 16, 2014, claimant filed three applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-18421, 14-UI-18422 and 14-UI-14-UI-18409. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2014-EAB-1044, 2014-EAB-1045 and 2014-EAB-1156).

EAB reviewed the entire hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 14-UI-18421, 14-UI-18422 and 14-UI-18409 are affirmed.
