EMPLOYMENT APPEALS BOARD DECISION 2014-EAB-1123

Affirmed Ineligible

PROCEDURAL HISTORY: On June 6, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from May 11 through 31, 2014 (decision # 130031). Claimant filed a timely request for hearing. On June 25, 2014, ALJ Murdock conducted a hearing, and on June 27, 2014 issued Hearing Decision 14-UI-20560, affirming the Department's decision, and concluding that claimant also was not available for work from June 1 through 21, 2014. On June 30, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant's written argument contained information that was not part of the hearing record, and did not assert or show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (October 29, 2006), we considered only information received into evidence at the hearing when reaching this decision. In his argument, claimant argued that the ALJ erred in concluding that claimant was not available for work during the weeks at issue, asserting that OAR 471-030-0036(3)(b) (February 23, 2014) only required him to be capable of reporting for suitable work opportunities, and not capable of *immediately* reporting for such opportunities. However, OAR 471-030-0036(3)(b) required claimant to be capable of reporting for "any" suitable work opportunities, which necessarily includes those for which claimant was expected to report immediately.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 14-UI-20560 is affirmed.
