## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-1144

Affirmed Overpayment

**PROCEDURAL HISTORY:** On December 17, 2009, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good caused. Claimant filed a timely request for hearing. On March 15, 2010, ALJ M. Smith conducted a hearing, and on March 17, 2010, issued Hearing Decision 10-UIB-05726, affirming the Department's decision. On April 6, 2010, Hearing Decision 10-UIB-05726 became final without an application for review having been filed.

On January 21, 2014, the Department served two notices of two administrative decisions; one assessing a \$924 overpayment (decision # 70952) based on Hearing Decision 10-UIB-05726, and one assessing a \$75 overpayment (decision # 71248) in Federal Additional Compensation Benefits (FAC) based on Hearing Decision 10-UIB-05726. On February 10, 2014, decisions # 70952 and # 71248 became final without a request for hearing having been filed. On April 15, 2014, claimant filed an untimely request for hearing. On April 24, 2014, ALJ Kangas issued Hearing Decisions 14-UI-15886 and 14-UI-15887, dismissing claimant's request for hearing as untimely, subject to claimant's "right to renew" the request by submitting a response to the "Appellant Questionnaire" attached to the hearing decisions within 14 days of the date the decisions were mailed. On April 29, 2014, the Office of Administrative Hearings (OAH) received claimant's response. On May 13, 2014, OAH issued two letters entitled, "Cancellation of Hearing Decision." On May 20, 2014, OAH issued notice of a consolidated hearing scheduled for June 3, 2014 at 2:30 p.m.

On June 3, 2014, ALJ Triana conducted a consolidated hearing in which claimant appeared and testified, and on June 9, 2014, issued Hearing Decisions 14-UI-19239 and 14-UI-19240, allowing claimant's late request for hearing, but affirming decisions # 70952 and # 71248. On June 30, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-19239 and 14-UI-19240. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-1144 and 2014-EAB-1145).

Claimant's argument contained information that was not part of the hearing record. Under ORS 657.275(2) and OAR 471-041-0090 (October 29, 2006), we considered only information received into evidence at the hearing when reaching this decision. Even if we had considered claimant's written argument, the outcome of these decisions would remain the same.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decision 14-UI-19239 and 14-UI-19240 are affirmed.
