**EMPLOYMENT APPEALS BOARD DECISION**  
**2014-EAB-1164**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment*

**PROCEDURAL HISTORY:** On May 1, 2014<sup>1</sup>, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 154327). On May 15, 2014, the Department served notice of an administrative decision (decision # 194539) assessing a \$1,164 overpayment, \$124.60 in monetary penalties, and 9 penalty weeks based on decision # 154327. On May 20, 2014, decision # 154327 became final without a request for hearing having been filed. On May 22, 2014, claimant filed a timely request for hearing on decision # 194539 and a late request for hearing on decision # 154327.

On May 28, 2014, the Office of Administrative Hearings (OAH) issued two notices of two hearings scheduled for June 13, 2014, one at 9:30 a.m. and one at 10:45 a.m. On June 13, 2014, ALJ Vincent conducted two hearings and on June 20, 2014, issued Hearing Decision 14-UI-20081, dismissing claimant's late request for hearing on decision # 154327, and Hearing Decision 14-UI-20078, modifying the Department's decision # 194539 and assessing a \$1,164 overpayment without penalties. On July 7, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-20081 and 14-UI-20078. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-1163 and 2014-EAB-1164).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

<sup>1</sup>The ALJ incorrectly identified May 21, 2014 as the date the Department mailed administrative decision # 154327. During the June 13, 2014 hearing, the Department's authorized representative testified that May 1, 2014 was the most likely date the decision was mailed. This would still make claimant's May 22, 2014 request for hearing one day late and does not change the outcome of Hearing Decision 14-UI-20081.

**DECISION:** Hearing Decisions 14-UI-20081 and 14-UI-20078 are affirmed.
