## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-1232

Affirmed Ineligible

**PROCEDURAL HISTORY:** On March 12, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant is ineligible for benefits for the week of February 16 through 22, 2014 (week 08-14). On May 14, 2014, claimant filed a request for hearing. On May 22, 2014, ALJ Kangas issued Hearing Decision 14-UI-18148, dismissing claimant's request for hearing as untimely, subject to claimant's "right to renew" the request by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed. On June 2, 2014, the Office of Administrative Hearings (OAH) received claimant's response. On June 19, 2014, OAH issued a letter entitled "Cancellation of Hearing Decision." On July 2, 2014, ALJ Holmes-Swanson conducted a hearing and issued Hearing Decision 14-UI-20779, allowing claimant's late request for hearing, and concluding that claimant is ineligible for benefits for week 08-14 and the week of May 4 through 10, 2014 (week 19-14). On July 17, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 14-UI-20779 is affirmed.
