## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-1236

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

**PROCEDURAL HISTORY:** On December 23, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from September 29, 2013 to December 7, 2013 (decision # 84737). On January 13, 2014, decision # 84737 became final without a request for hearing having been filed. On April 10, 2014, the Department served notice of an administrative decision assessing a \$3,666 overpayment based on decision # 84737, (decision # 94207). On April 28, 2014, claimant filed a timely request for hearing on decision # 94207. On June 12, 2014, claimant filed a late request for hearing on decision # 84737.

On June 13, 2014, the Office of Administrative Hearings (OAH) issued two notices of hearings scheduled for June 26, 2014, one at 8:15 a.m. and one at 9:30 a.m. On June 26, 2014, ALJ Logan conducted two hearings. On June 27, 2014, ALJ issued Hearing Decision 14-UI-20532 dismissing claimant's late request for hearing on decision # 84737. On June 27, 2014, ALJ Logan issued Hearing Decision 14-UI-20531 affirming the Department's decision # 94207. On July 17, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-20531 and 14-UI-20532. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-1235 and 2014-EAB-1236).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 14-UI-20531 and 14-UI-20532 are affirmed.
