## EMPLOYMENT APPEALS BOARD DECISION 2014-EAB-1345

Affirmed Late Request for Hearing Dismissed Overpayment

**PROCEDURAL HISTORY:** On March 11, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from December 15, 2013 to March 8, 2014 (weeks 51-13 to 10-14) (decision # 82808). On March 31, 2014, decision # 82808 became final without a request for hearing having been filed. On Jun 26, 2014, the Department served notice of an administrative decision (decision # 143652) assessing a \$1,134 overpayment based on decision # 82808. On July 1, 2014, claimant filed a telephone request for hearing. On July 10, 2014, the Office of Administrative Hearings (OAH) issued two notices of two hearings scheduled for July 22, 2014, one at 1:30 p.m. and one at 2:30 p.m. On July 22, 2014, ALJ Vincent conducted a hearing, and on August 5, 2014, issued Hearing Decision 14-UI-22846, dismissing claimant request for hearing on decision # 82808 as untimely, and Hearing Decision 14-UI-22843, affirming decision # 143652. On August 11, 2014, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-22843 and 14-UI-22846. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-1344 and 2014-EAB-1345).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 14-UI-22843 and 14-UI-22846 are affirmed.
