## **EMPLOYMENT APPEALS BOARD DECISION**

2014-EAB-1361

Affirmed
Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On September 19, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 154913) concluding that claimant was not available for work from June 23, 2013 through August 31, 2013 (weeks 26-13 through 35-13). On October 9, 2013, decision # 154913 became final without a request for hearing having been filed. On November 12, 3013, the Department served notice of an administrative decision (decision # 141813) assessing a \$1,343 overpayment based on decision # 154913. On June 12, 2014, claimant filed a request for hearing. On June 17, 2014, ALJ Kangas issued Hearing Decisions 14-UI-19741, dismissing claimant's request for hearing on decision #154913 as untimely, and Hearing Decision 14-UI-19742, dismissing claimant's request for hearing on decision #141813 as untimely, subject to claimant's "right to renew" each request by submitting a response to the "Appellant Questionnaire" attached to each hearing decision within 14 days of the date each decision was mailed. On July 2, 2014, claimant filed an application for review with the Employment Appeals Board (EAB). Also on July 2, 2014, claimant submitted a response to the "Appellant Questionnaire" attached to Hearing Decision 14-UI-19741 to the Office of Administrative Hearings (OAH). By letter dated July 17, 2014, ALJ Kangas informed claimant that her response to the "Appellant Questionnaire" was late, and that Hearing Decision 14-UI-19741 remained in effect.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-19741 and 14-UI-19741. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2014-EAB-1360 and 2014-EAB-1361).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 14-UI-19741 is affirmed.
