EMPLOYMENT APPEALS BOARD DECISION

2014-EAB-1392

PROCEDURAL HISTORY: On July 7, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 115430). Claimant filed a timely request for hearing. On July 31, 2014, ALJ Shoemake conducted an interpreted hearing, and on August 8, 2014 issued Hearing Decision 14-UI-23115, concluding the employer discharged claimant but not for misconduct. On August 19, 2014, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 14-UI-23115 is affirmed.
