Affirmed Disqualification

PROCEDURAL HISTORY: On June 18, 2014, the Oregon Employment Department (the Department) served three notices of three administrative decisions concluding claimant was not actively seeking work for the week of April 27, 2014 to May 3, 2014 (week 18-14) (decision # 101642), for the week of May 11, 2014 to May 17, 2014 (week 20-14) (decision # 103054), and for the weeks of May 18, 2014 through June 7, 2014 (weeks 21-14 through 23-14) (decision # 103259). Claimant filed three timely requests for hearing. On August 7, 2014, ALJ R. Davis conducted a consolidated hearing, and on August 14, 2014 issued Hearing Decisions 14-UI-23391, 14-UI-23385 and 14-UI-23390 affirming the Department's decisions. On August 28, 2014, claimant filed three applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-23391, 14-UI-23385 and 14-UI-23390. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2014-EAB-1428, 2014-EAB-1429, and 2014-EAB-1430).

EAB reviewed the entire hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted.**

DECISION: Hearing Decisions 14-UI-23391, 14-UI-23385 and 14-UI-23390 are affirmed.
