**EMPLOYMENT APPEALS BOARD DECISION**

**2014-EAB-1465**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On May 27, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work with good cause (decision # 90027). The employer filed a timely request for hearing. On June 6, 2014, the Office of Administrative Hearings served notice of a hearing scheduled for June 19, 2014 at 8:15 a.m. On June 19, 2014, ALJ M. Davis conducted a hearing in which claimant did not participate, and on June 20, 2014, issued Hearing Decision 14-UI-20094, concluding that claimant voluntarily left work without good cause. On July 8, 2014, claimant filed an application for review with the Employment Appeals Board (EAB).

On July 23, 2014, EAB issued Appeals Board Decision 2014-EAB-1174, reversing Hearing Decision 14-UI-20094 and remanding the matter for such other and further proceedings as may be necessary. On August 29, 2014, ALJ M. Davis conducted a hearing and issued Hearing Decision 14-UI-24358, concluding that claimant voluntarily left work with good cause. On September 12, 2014, the employer filed an application for review with the Employment Appeals Board (EAB). This decision is issued pursuant to EAB's authority under ORS 657.290(3).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 14-UI-24358 is affirmed.
