PROCEDURAL HISTORY: On June 25, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct (decision # 130900). On July 15, 2014, decision #130900 became final without an appeal having been filed. On July 21, 2014, the Department served notice of an administrative decision (decision #85730) assessing a \$1,284 overpayment based on decision # 130900. On July 29, 2014, claimant filed a request for hearing on decisions #130900 and #85730.

On August 13, 2014, the Office of Administrative Hearings (OAH) issued notice of two hearings scheduled for August 29, 2014 – one at 8:15 a.m. and the other at 9:30 a.m. On August 29, 2014, ALJ Wyatt conducted a hearing at 8:15 a.m., and on September 3, 2014, issued Hearing Decision 14-UI-24502, dismissing claimant's request for hearing on decision #130900 as untimely. Also on August 29, 2015, ALJ Wyatt issued Hearing Decision 14-UI-24318, dismissing claimant's request for hearing on decision #85730 for failure to appear at the 9:30 a.m. hearing.

On September 15, 2014, claimant filed an application for review on Hearing Decisions 14-UI-24502 and 14-UI-24318.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions Hearing Decisions 14-UI-24502 and 14-UI-24318. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 1489 and 1490).

EAB reviewed the entire hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted.**

DECISION: Hearing Decisions 14-UI-24502 and 14-UI-24318 are affirmed.
