EMPLOYMENT APPEALS BOARD DECISION

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 27, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 75218). On July 17, 2014, decision # 75218 became final without a request for hearing having been filed. On September 29, 2014, claimant filed an untimely request for hearing. On October 7, 2014, ALJ Kangas issued Hearing Decision 14-UI-26523, dismissing claimant's request for hearing as untimely, subject to claimant's "right to renew" the request by submitting a response to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed. On October 27, 2014, OAH received claimant's late response. By letter dated November 5, 2014, the Office of Administrative Hearings (OAH) informed claimant that her response to the "Appellant Questionnaire" was late, and that Hearing Decision 14-UI-26523 remained in effect. On November 25, 2014, claimant filed an application for review of the November 5th letter with the Employment Appeals Board (EAB).

With her application for review, claimant wrote "I am not presently receiving posted mail in a timely manner due to my current living situation." Claimant's statement is considered a request to have EAB consider new information under OAR 471-041-0090 (October 29, 2006), which allows EAB to consider new information if the party offering the information shows that it was prevented by circumstances beyond its reasonable control from presenting the information at a hearing, or, in this case, from presenting the information in a timely response to the appellant questionnaire. In support of her argument, however, claimant provided no specific details, such as what were her problems receiving mail, how long it usually took for her to receive mail, whether the notified the Department or OAH of her difficulty, what she did to try to resolve the mail delay, when she received the hearing decision with the appellant questionnaire, or why she responded to the appellant questionnaire when she did. Without those sorts of details, we have no evidence that would support a conclusion that the content of claimant's response to the appellant questionnaire should be considered despite having been submitted after the

deadline had passed.² Claimant's request for EAB to consider her new information must, therefore, be denied.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Claimant's late request for hearing is dismissed. Hearing Decision 14-UI-26523 remains undisturbed.
