EMPLOYMENT APPEALS BOARD DECISION 2014-EAB-0899-R

Application for Review Dismissed Request to Withdraw Allowed

PROCEDURAL HISTORY: On March 31, 2014, the Oregon Employment Department (the Department) served two notices of two administrative decisions; one concluding claimant voluntarily left work without good cause (decision #75624), and one concluding claimant was not available for work from March 2, 2014 to March 22, 2014 (weeks 10-14 to 12-14) (decision #104256). On April 3, 2014, claimant filed a timely telephone request for hearing. On April 24, 2014, the Office of Administrative Hearings (OAH) issued two notices of two hearings scheduled for May 8, 2014: one notice (Ref. No. 2014-UI-15074) notified the parties that the hearing on decision #104256 was scheduled for 9:30 a.m., a nd the other notice (Ref. No. 2014-UI-15076) notified the parties that the hearing on decision #75624 was scheduled for 10:45 a.m. On May 8, 2014, ALJ Lohr conducted a hearing on decision # 75624, and on May 9, 2014, issued Hearing Decision 14-UI-17229, affirming the Department's decision # 75624. That same day, ALJ Lohr issued Hearing Decision 14-UI-17242, allowing claimant's request to withdraw her request for hearing regarding decision # 104256. On May 20, 2014, claimant filed applications for review with the Employment Appeals Board (EAB). On June 13, 2014, EAB issued Appeals Board Decisions 2014-EAB-0898, affirming Hearing Decision 14-UI-17229, and 2014-EAB-0899, reversing Hearing Decision 14-UI-17242, and remanding the matter back to OAH for incomplete record.¹ On June 20, 2014, OAH provided EAB with a complete record.²

CONCLUSIONS AND REASONS: Claimant's request to withdraw is allowed.

Claimant's request to withdraw her request for hearing with respect to decision # 104256 is allowed. OAR 4741-041-0090 (October 29, 2006). Claimant's application for review is therefore dismissed.

DECISION: The application for review filed May 20, 2014 is dismissed. Hearing Decision 14-UI-17242 remains undisturbed.
