PROCEDURAL HISTORY: On October 28, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 113845) concluding that claimant did not actively seek work from August 31 through October 18, 2014 (weeks 36-14 through 42-14). Claimant filed a timely request for hearing. On December 8, 2014, ALJ Frank conducted a hearing, and on December 12, 2014, issued Hearing Decision 14-UI-30301, affirming the administrative decision. On January 2, 2014, claimant filed an application for review with the Employment Appeals Board (EAB). On January 9, 2015, EAB issued Appeals Board Decision 2015-EAB-1623, reversing Hearing Decision 14-UI-30301 and remanding the matter back to the Office of Administrative hearings (OAH) for development of the record. On February 4, 2015, ALJ Frank conducted a hearing, and on February 6, 2015, issued Hearing Decision 15-UI-33124, affirming administrative decision #113845. On February 25, 2015, claimant filed an application for review with EAB.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 15-UI-33124 is affirmed.
