## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0252

## Reversed & Remanded

**PROCEDURAL HISTORY:** On January 16, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work with good cause (decision # 124723). The employer filed a timely request for hearing. On January 27, 2015, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for February 11, 2015. On February 11, 2015, ALJ Wyatt conducted a hearing in which the claimant did not participate, and issued Hearing Decision 15-UI-33752, concluding that claimant voluntarily left work without good cause. On March 5, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

In her application for review, claimant asserted that she missed the hearing because she did not receive notice of the hearing until February 13, 2015. Claimant explained that she lives in an apartment complex, and that because she and a neighbor have similar names, mail intended for claimant is sometimes mistakenly placed in the neighbor's mailbox. The neighbor is rarely home. Claimant stated that on February 13, the neighbor "gave me several pieces of mail, the hearing letter included."

Claimant's complaint is considered a request to have EAB consider additional evidence under OAR 471-040-0090 (October 29, 2006), which allows EAB to consider new information if the party offering the information shows it was prevented by circumstances beyond its reasonable control from presenting the information at the hearing. The misdirected notice of hearing and the neighbor's failure to promptly discover the notice and give it to claimant are circumstances beyond claimant's reasonable control. Claimant has shown good cause for presenting new information. It is therefore appropriate to reverse Hearing Decision 15-UI-33752 and remand the matter under ORS 657.275(1) for a new hearing and a hearing decision.

**DECISION:** Hearing Decision 15-UI-33752 is set aside, and this matter remanded for further proceedings consistent with this order.
