## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0261

Affirmed
Late Request for Hearing Dismissed
Overpayment and Penalties

**PROCEDURAL HISTORY:** On August 25, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$1,614 overpayment, \$322.80 in monetary penalties and 12 penalty weeks based on unreported wages (decision # 194019). On September 15, 2014, decision # 194019 became final without a request for hearing having been filed. On January 16, 2015, claimant filed a late request for hearing. On January 29, 2015, ALJ Kangas issued Hearing Decision 15-UI-32564, dismissing claimant's request for hearing on decision # 194019 as untimely, subject to claimant's "right to renew" the request by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decisions were mailed. On February 7, 2015, the Office of Administrative Hearings (OAH) received claimant's response. On February 19, 2015, ALJ Kangas reviewed claimant's response and issued Hearing Decision 15-UI-33685, cancelling Hearing Decision 15-UI-32564, and re-dismissing claimant's January 16, 2015 request for hearing. On March 9, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 15-UI-33685 is affirmed.
