## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0308

Affirmed Late Request for Hearing Dismissed Disqualification

**PROCEDURAL HISTORY:** On December 24, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant committed a disqualifying act (decision # 72432). On January 13, 2015, decision # 72432 became final without a request for hearing having been filed. On January 15, 2015, claimant filed a late request for hearing. On February 10, 2015, ALJ Kangas issued Hearing Decision 15-UI-33238, dismissing claimant's request for hearing on decision # 72432 as untimely, subject to claimant's "right to renew" the request by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed.<sup>1</sup> On February 23, 2015, the Office of Administrative Hearings (OAH) received claimant's response. On March 4, 2015, ALJ Kangas reviewed claimant's response and issued Hearing Decision 15-UI-33238, and re-dismissing claimant's January 15, 2015 request for hearing. On March 13, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant failed to certify that she provided a copy of her written argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we did not consider the argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 15-UI-34480 is affirmed.
