EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0314

Affirmed Request to Reopen Denied Disqualification

PROCEDURAL HISTORY: On March 11, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 163649). Claimant filed a timely request for hearing. On April 7, 2014, the Office of Administrative Hearings (OAH) issued notice of a hearing scheduled for April 22, 2014 at 8:15 a.m. Claimant did not appear at the hearing. On April 22, 2014, ALJ Triana issued Hearing Decision 14-UI-15703, dismissing claimant's hearing request for failure to appear. On May 12, 2014, Hearing Decision 14-UI-15703 became final without a request to reopen or an application for review with the Employment Appeals Board (EAB) having been filed.

On October 21, 2014, OAH issued a letter to claimant, informing him that the Department forwarded a telephonic request for reopening by claimant to OAH. The letter informed claimant he must provide a request in writing stating his request for a reopening and explaining why he missed his hearing. On November 21, 2014, claimant provided a written request.

On December 22, 2014, OAH issued notice of a hearing scheduled for January 9, 2015, at 1:30 p.m. Claimant did not appear at the hearing. On January 9, 2015, ALJ Wyatt issued Hearing Decision 15-UI-31630, dismissing claimant's hearing request for failure to appear. On January 15, 2015, claimant filed a request to reopen. On February 25, 2015, ALJ Wyatt conducted a hearing, and on February 27, 2015 issued Hearing Decision 15-UI-34313, denying claimant's request to reopen and leaving Hearing Decision 14-UI-15703 undisturbed. On March 19, 2015, claimant filed an application for review with the EAB.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 15-UI-34313 is affirmed. Hearing Decision 14-UI-15703 remains undisturbed.
