## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0320

Affirmed Late Request for Hearing Dismissed Overpayment and Penalties

**PROCEDURAL HISTORY:** On September 5, 2013, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 194047) concluding claimant willfully made a misrepresentation to obtain benefits, and assessing a \$244 overpayment, \$36.60 in monetary penalties and 52 penalty weeks. On September 25, 2013, administrative decision # 194047 became final without a request for hearing having been filed. On February 25, 2015, claimant filed a late request for hearing.

On March 6, 2015, ALJ Kangas issued Hearing Decision 15-UI-34667, dismissing claimant's request for hearing as untimely, subject to claimant's "right to renew" the request by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed.<sup>1</sup> On March 10, 2015, the Office of Administrative Hearings (OAH) received claimant's response. On March 19, 2015, ALJ Kangas reviewed claimant's response and issued Hearing Decision 15-UI-35388, cancelling Hearing Decision 15-UI-34667, and re-dismissing claimant's February 25, 2015 request for hearing. On March 23, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 15-UI-35388 is affirmed. Administrative decision # 194047 remains undisturbed.
