PROCEDURAL HISTORY: On January 2, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 102723) concluding claimant voluntarily left work without good cause. On January 22, 2015, administrative decision # 102723 became final without a request for hearing having been filed. On February 11, 2015, claimant filed a late request for hearing. On February 24, 2015, ALJ Kangas issued Hearing Decision 15-UI-34007, dismissing claimant's request for hearing as untimely, subject to claimant's "right to renew" the request by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed. On March 2, 2015, the Office of Administrative Hearings (OAH) received claimant's response. On March 4, 2015, OAH issued a "Cancellation of Hearing Decision" for Hearing Decision 15-UI-34007. On March 20, 2015, ALJ Han conducted a hearing and issued Hearing Decision 15-UI-35512, re-dismissing claimant's late request for hearing. On March 27, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant failed to certify that she provided a copy of her written argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we did not consider the argument when reaching this decision. Even if we had, the outcome of this decision would remain the same for the reasons explained in Hearing Decision 15-UI-35512.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 15-UI-35512 is affirmed.
