## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0352

Affirmed Late Request for Hearing Dismissed Overpayment, No Penalties Decisión Affimada Petición Tardía para una Audiencia Negada Sobrepago, no Sanciones

**PROCEDURAL HISTORY:** On December 18, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 143935) concluding claimant was not actively seeking work for the period of September 28, 2014 through November 22, 2014 (weeks 40-14 through 47-14). On January 7, 2015, decision # 143935 became final without a request for hearing having been filed. On January 21, 2015, the Department served notice of an administrative decision (decision # 112816) assessing a \$1,505 overpayment based on decision # 143935.<sup>1</sup> On January 30, 2015, claimant filed a late request for hearing on decision # 143935 and a timely request for hearing on decision # 112816.

On March 12, 2015, ALJ M. Davis conducted a consolidated hearing and on March 13, 2015 issued two Hearing Decisions; Hearing Decision 15-UI-35072, dismissing claimant's late request for hearing on decision # 143935, and Hearing Decision 15-UI-35073, affirming the overpayment decision # 112816. On March 30, 2015, claimant filed applications for review with the Employment Appeals Board (EAB).

<sup>&</sup>lt;sup>1</sup> Administrative decision # 143935 found claimant ineligible for the period of September 28, 2014 through November 22, 2014 (weeks 40-14 through 47-14). However, the administrative overpayment decision # 112816 found claimant was only overpaid for the period of September 28, 2014 through November 15, 2014 (weeks 40-14 through 46-14). Although the Department representative provided no explanation in the hearing or elsewhere in the record for the discrepancy, Department records show that the Department did not pay claimant benefits for week 47-14, so that week was not included in the overpayment decision. We take notice of claimant's payment status for week 47-14, which is contained in Employment Department records. Any party that objects to our doing so must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(3) (October 29, 2006). Unless such objection is received and sustained, the noticed fact will remain in the record.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-35072 and 15-UI-35073. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-0351 and 2015-EAB-0352).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted.** 

**DECISION:** Hearing Decisions 15-UI-35072 and 15-UI-35073 are affirmed. *Decisións de la Audiencia 15-UI-35072 y 15-UI-35073 queda confirmada*.
