PROCEDURAL HISTORY: On January 8, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 124515) concluding the employer discharged claimant for misconduct. On January 28, 2015, administrative decision # 124515 became final without a request for hearing having been filed. On February 6, 2015, claimant filed a late request for hearing. On February 23, 2015, ALJ Kangas issued Hearing Decision 15-UI-33850, dismissing claimant's request for hearing as untimely, subject to claimant's "right to renew" the request by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decision was mailed.¹

On March 9, 2015, the Office of Administrative Hearings (OAH) received claimant's response. On March 23, 2015, OAH issued a "Cancellation of Hearing Decision" for Hearing Decision 15-UI-33850. On April 6, 2015, ALJ M. Davis conducted a hearing, and on April 7, 2015 issued Hearing Decision 15-UI-36459, re-dismissing claimant's late request for hearing. On April 13, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB received claimant's written argument, in which claimant seems to allege that she missed the April 6, 2015 hearing and requested another one be scheduled. However, the record shows that claimant attended the hearing and provided testimony about her reasons for filing a late application for review. Because claimant did not miss the hearing in this matter, she is not entitled to have the hearing reopened.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.
