

**EMPLOYMENT APPEALS BOARD DECISION**  
**2015-EAB-0450**

*Affirmed*  
*Request for Hearing Dismissed*  
*Disqualification*

**PROCEDURAL HISTORY:** On March 5, 2015, the Oregon Employment Department (the Department) served notice of two administrative decisions (decisions # 130659 and # 131903) concluding claimant did not actively seek work for the periods of October 19 through December 6, 2014 (weeks 43-14 through 49-14), and January 4 through February 7, 2015 (weeks 1-15 through 5-15). On March 11, 2015, claimant filed timely requests for hearing. On March 24, 2015, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing scheduled for April 7, 2015 at 2:30 p.m. On March 31, 2015, claimant and an authorized representative of the Department phoned OAH to withdraw his requests for hearing on both decisions # 130659 and # 131903.<sup>1</sup> On April 1, 2015, ALJ S. Lee issued Hearing Decisions 15-UI-36090 and 15-UI-36091, dismissing claimant's requests for hearing at claimant's request. On April 17, 2015, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-36090 and 15-UI-36091. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-0449 and 2015-EAB-0450).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decisions 15-UI-36090 and 15-UI-36091 are affirmed.
