EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0535

Hearing Decision 15-UI-37709 Affirmed, Late Request for Hearing Dismissed Hearing Decision 15-UI-37713 Affirmed, Overpayment no Penalties

PROCEDURAL HISTORY: On February 24, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 124718). On March 16, 2015, decision # 124718 became final without an appeal having been filed. On March 30, 2015, the Department served notice of another administrative decision assessing a \$1,090 overpayment, \$163.50 in monetary penalties, and 8 penalty weeks, based on decision # 124718 (decision # 213233). On April 7, 2015, claimant filed a late request for hearing on decision # 124718, and a timely request for hearing on decision # 213233.

On April 28, 2015, ALJ M. Davis conducted two hearings, and on April 30, 2015 issued two hearing decisions; Hearing Decision 15-UI-37709 dismissed claimant's late request for hearing on decision # 124718, and Hearing Decision 15-UI-37713 concluding claimant did not willfully make a false representation to obtain benefits, and assessing a \$1,090 overpayment without monetary penalties or penalty weeks. On May 8, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-37709 and 15-UI-37713. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-0534 and 2015-EAB-0535).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 15-UI-37709 and 15-UI-37713 are affirmed.
