EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0728

Affirmed Ineligible Weeks 04-15, 05-15, 09-15, 10-15 and 12-15

PROCEDURAL HISTORY: On April 17, 2015, the Oregon Employment Department (the Department) served notice of the following three administrative decisions: decision #111155 concluded that claimant did not actively seek work from January 25 to February 7, 2015 (weeks 04-15 and 05-15); decision #113302 concluded that claimant did not actively seek work from March 1 through March 14, 2015 (weeks 09-15 and 10-15); and decision #113530 concluded that claimant did not actively seek work from March 22 through March 28, 2015 (week 12-15). Claimant filed timely requests for hearing. On May 21, 2015, ALJ S. Lee conducted a consolidated hearing, and on May 27, 2015, issued the following three decisions: Hearing Decision 15-UI-39110 affirmed decision #11155; Hearing Decision 15-UI-39105 affirmed decision #113302; and Hearing Decision 15-UI-39113 affirmed decision #113530. On June 11, 2015, claimant filed applications for review of these three hearing decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions, 15-UI-39105, 15-UI-39110 and 15-UI-39113. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2015-EAB-0726, 2015-EAB-0727 and 2015-EAB-0728).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 15-UI-39105, 15-UI-39110 and 15-UI-39113 are affirmed. *Decisiónes de la Audiencia 15-UI-3910, 15-UI-39110 and 15-UI-39113 quedan confirmadas.*
