## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0756

## Affirmed Disqualification Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On May 1, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision #81919). On May 6, 2015, the Department issued a decision (decision #111648) concluding that claimant was ineligible for benefits under the Self Employment Assistance (SEA) Program. Claimant filed timely requests for hearing on both decisions. Claimant withdrew her request for a hearing on decision #11648, the decision regarding her eligibility for the SEA program and on June 2, 2015, ALJ Murdock issued Hearing Decision 15-UI-39432, dismissing claimant's request for a hearing on decision #111648.

Also on June 2, 2015, ALJ S. Lee conducted a hearing on decision #81919, the decision concerning claimant's work separation, and on June 4, 2015, issued Hearing Decision 15-UI-39573, affirming decision this decision. On June 18 2015, claimant filed an application for review of Hearing Decision 15-UI-39573 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-39432 and 15-UI-39573. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-0756 and 2015-EAB-0757).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 15-UI-39573 and 15-UI-39432 are affirmed.
