EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0762

Ineligible Weeks 4-15 through 6-15, 8-15 through 12-15, 14-15 and 15-15

PROCEDURAL HISTORY: On May 8, 2015, the Oregon Employment Department (the Department) served notice of the following three administrative decisions: decision #141658 concluded that claimant did not actively seek work from April 5, through 18, 2015 (weeks 14-15 and 15-15); decision #140559 concluded that claimant did not actively seek work from February 22 through March 28, 2015 (weeks 8-15 through 12-15) and decision # 131746 concluded that claimant did not actively seek work from January 25 through February 14, 2015 (weeks 4-15 through 6-15). Claimant filed timely requests for hearing. On June 15, 2015, ALJ Triana conducted a consolidated hearing and on June 19, 2015 issued the following three hearing decisions: Hearing Decision 15-UI-40359 affirmed administrative decision #140559; Hearing Decision 15-UI-40360 affirmed decision #141658 and Hearing Decision 15-UI-40361 affirmed decision #131746. On June 23, 2015, claimant filed applications for review of all three decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-49359, 15-UI-40360 and 15-UI-40361. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2015-EAB-0761, 2015-EAB-7062, and 2015-EAB-0763).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted.**

DECISION: Hearing Decisions 15-UI-40359, 15-UI-40360 and 15-UI-40361 are affirmed.
