## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0777

Hearing Decisions 15-UI-40440 and 15-UI-40461 Affirmed Overpayment Assessed

**PROCEDURAL HISTORY:** On October 27, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 130115) concluding that claimant received vacation pay in excess of his weekly benefit amount for the period from September 21 through October 18, 2014 (weeks 39-14 through 42-14). On November 17, 2014, decision #130115 became final without a request for hearing having been filed. On November 28, 2014, the Department served notice of an administrative decision (#163251) assessing a \$1,647 overpayment based on decision #130115. On December 18, 2014, decision #163251 became final without a request for hearing having been filed. On April 9, 2015, claimant filed late requests for hearing on decisions #130115 and #163251.

On April 16, 2015, ALJ Kangas issued Hearing Decisions 15-UI-37010 and 15-UI-37014, dismissing claimants hearing requests, subject to claimant's right to renew these requests if claimant filed responses to appellant questionnaires within 14 days of the date the decisions were mailed. On April 24, 2015, claimant filed timely responses. On May 6, 2015, the Office of Administrative Hearings mailed letters canceling Hearing Decisions 15-UI-37010 and 15-UI-37014. On June 16 and June 18, 2015, ALJ Murdock conducted hearings, and on June 22, 2015, issued two hearing decisions: Hearing Decision 15-UI-40440, which allowed claimant's request for a hearing on decision #130115 (the vacation pay decision), and affirmed that decision; and Hearing Decision 15-UI-40461, which allowed claimant's request for hearing on decision #163251 (the overpayment decision), and affirmed that decision. On June 29, 2015, claimant filed applications for review of both hearing decisions.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-40440 and 15-UI-40461. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-07776 and 2015-EAB-0777).

EAB reviewed the entire hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted.** 

**DECISION:** Hearing Decisions 15-UI-40440 and 15-UI-40461 are affirmed.
