

**EMPLOYMENT APPEALS BOARD DECISION**  
**2015-EAB-0940**

*Hearing Decisions 15-UI-41559 and 15-UI-41629 Affirmed  
Ineligible  
Overpayment, No Penalties*

**PROCEDURAL HISTORY:** On April 10, 2015, the Oregon Employment Department (the Department) served notice of administrative decision # 75732, concluding that claimant was not able to work from March 1 through April 4, 2015. On April 30, 2015, decision # 75732 became final without a request for hearing having been file. On June 15, 2015, the Department served notice of administrative decision # 195364, assessing a \$1,348 overpayment based on decision # 75732, penalty weeks, and a monetary penalty. On June 17, 2015, claimant filed a late request for hearing on decision # 75732, and a timely request for hearing on decision # 195364. On July 14, 2015, ALJ Murdock conducted hearings on decisions # 75732 and # 195364. On July 16, 2015 ALJ Murdock issued Hearing Decision 15-UI-41559, dismissing claimant's late request for hearing on decision # 75732. On July 17, 2015, ALJ Murdock issued Hearing Decision 15-UI-41629, modifying decision # 195364 by assessing a \$1,348 overpayment based on decision # 75732, but no penalty weeks or monetary penalty. On August 4, 2015, claimant filed applications for review of Hearing Decisions 15-UI-41559 and 15-UI-41629 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-41559 and 15-UI-41629. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-0940 and 2015-EAB-0941).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 15-UI-41559 and 15-UI-41629 are affirmed.
