## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-0972

Hearing Decisions 15-UI-42113, 15-UI-42114, 15-UI-42117, 15-UI-42121 and 15-UI-42124 Affirmed Disqualification Hearing Decision 15-UI-42120 Dismissed

**PROCEDURAL HISTORY:** On May 28, 2015, the Oregon Employment Department (the Department) served notice of the following administrative decisions that found that claimant failed to accept suitable work with Multnomah County School District #1 without good cause on the following dates: February 3, 2015 (decision # 143805); February 25, 2015 (decision # 104808); February 26, 2015 (decision # 105716); March 9, 2015 (decisions # 150214 and # 151937) ; and March 10, 2015 (decision # 145423). Claimant filed timely requests for hearing. On July 23, 2015, ALJ M. Davis conducted a consolidated hearing and on July 29, 2015 issued the follow hearing decisions: Hearing Decision 15-UI-42113 affirmed decision # 104808; Hearing Decision 15-UI-42114 affirmed decision # 105716; Hearing Decision 15-UI-42117 affirmed decision # 1438-5; Hearing Decision 15-UI-42121 affirmed decision # 150214; Hearing Decision 15-UI-42123 affirmed decision # 151937; and Hearing Decision 15-UI-42120 reversed decision # 145423, concluding that claimant did not fail to accept suitable work on March 10, 2015 without good cause. On August 18, 2015, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-42113, 15-UI-42114, 15-UI-42117, 15-UI-42121, 15-UI-42123, and 15-UI-42120. For case-tracking purposes, this decision is being issued in sextuplicate (EAB Decisions 2015-EAB-0972, 2015-EAB-0973, 2015-EAB-0974, 2015-EAB-0975, 2015-EAB-0976 and 2015-EAB-0977).

EAB considered claimant's written argument to the extent that it was relevant and based on the record.

Upon review of Hearing Decision 15-UI-42120, we determined that this decision was in claimant's favor. We conclude that the application for review of this decision presents no justiciable controversy and should therefore be **dismissed**.

EAB reviewed the entire hearing record. Upon *de novo* review and pursuant to ORS 657.275(2), Hearing Decisions 15-UI-42113, 15-UI-42114, 15-UI-42117, 15-UI-42121, 15-UI-42123 are **adopted**.

**DECISION:** The application for review of Hearing Decision 15-UI-42120 is dismissed, and this hearing decision remains undisturbed. Hearing Decisions 15-UI-42113, 15-UI-42114, 15-UI-42117, 15-UI-42121, 15-UI-42123 are affirmed.
