## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-1016

Affirmed Late Request for Hearing Denied Overpayment

**PROCEDURAL HISTORY:** On May 19, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision (decision #70614) concluding that claimant did not actively seek work from February 22 through April 25, 2015 (weeks 8-15 through 16-15). On June 8, 2015, decision #70614 became final without a request for hearing having been filed. On June 19, 2015, the Department served notice of an administrative decision (decision #154457) assessing a \$1,048 overpayment based on decision #70614. On July 1, 2015, claimant filed an untimely request for hearing on decision #70614 and a timely request for hearing on decision #154457. On August 4, 2015, ALJ Vincent held interpreted hearings, and on August 12, 2015 issued the following hearing decisions: Hearing Decision 15-UI-42886, which denied as untimely claimant request for a hearing on decision #70614, and Hearing Decision 15-UI-42902, which affirmed decision #15447. On August 24, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-42886 and 15-UI-42902. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-1016 and 2015-EAB-1017).

EAB considered the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 15-UI-42886 and 15-UI-42902 are affirmed.
