## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-1037

Affirmed Ineligible weeks 47-14, 52-14, 1-15, and 4-15 Overpaid \$576

**PROCEDURAL HISTORY:** On June 15, 2015, the Oregon Employment Department (the Department) served notice of the following three administrative decisions: decision #80501 concluded that claimant was not available for work from November 16 through 22, 2014 (week 47-14); decision #81207 concluded that claimant was not available for work from December 23, 2014 through January 10, 2015 (weeks 52-14 and 1-15); and decision #81952 concluded that claimant was not available for work from January 25 through 31, 2015. On June 16, 2015, the Department served notice of an administrative decision (decision #200837), assessing a \$576 overpayment. Claimant filed timely requests for hearing. On August 4, 2015, ALJ R. Davis conducted a consolidated hearing, and on August 11, 2015 issued the following hearing decisions: Hearing Decision 15-UI-42808 affirmed decision #81952; Hearing Decision 15-UI-42809 affirmed decision #80501; Hearing Decision 15-UI-42810 affirmed decision #200837; and Hearing Decision 15-UI-42812 affirmed decision #81207. On August 26, 2015, claimant filed applications for review of all four hearing decisions.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-42808, 15-UI-42809, 15-UI-42810 and 15-UI-42812. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2015-EAB-1037, 2015-EAB-1038, 2015-EAB-1039 and 2015-EAB-1040).

EAB considered claimant's written argument to the extent it was relevant and based on the hearing record.

EAB considered the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are adopted.

**DECISION:** Hearing Decisions 15-UI-42808, 15-UI-42809, 15-UI-42810 and 15-UI-42812 are adopted.
