EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-1181

Affirmed Ineligible Reduction in Benefits

PROCEDURAL HISTORY: On August 10, 2015, the Oregon Employment Department (the Department) served notice of two administrative decisions: decision # 82857 concluded that from June 1 through November 1, 2014, (weeks 23-14 through 44-14), claimant received retirement pay which reduced his unemployment benefits; and decision # 121340 concluded that from July 12 through July 25, 2015, (weeks 28-15 and 29-15), claimant was ineligible to receive unemployment benefits because he received retirement pay. Claimant filed timely hearing requests. On September 21, 2015, ALJ Vincent conducted a hearing and on September 25, 2015, issued Hearing Decision 15-UI-44947, which affirmed decision # 82857,¹ and Hearing Decision 15-UI-44952, which affirmed decision # 121340. On October 5, 2015, claimant filed applications for review of both hearing decisions.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-44947 and 15-UI-44952. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-1181 and 2015-EAB-1182).

EAB reviewed the entire hearing record in both cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 15-UI-44947 and 15-UI-44952 are affirmed.

¹ In the order section of Hearing Decision 15-UI-44947, the ALJ affirmed decision # 82857, but stated that claimant was not eligible to receive unemployment benefits for weeks 28-15 and 29-15. This was a typographical error, which we correct in this decision. We clarify that by adopting Hearing Decision 15-UI-44947, we conclude that from June 1 through November 1, 2014, claimant received retirement pay which reduced his unemployment benefits.
