## EMPLOYMENT APPEALS BOARD DECISION 2015-EAB-1405

## Affirmed Disqualification Overpayment Assessed

**PROCEDURAL HISTORY:** On July 6, 2015, the Oregon Employment Department (the Department) served notice of two administrative decisions: decision # 105335, which concluded that claimant voluntarily left work without good cause, and decision # 111254, which concluded that claimant was not able to or available for work from May 17 through May 30, 2015 (weeks 20-15 and 21-15). On July 27, 2015, decisions # 105335 and # 111254 became final without requests for hearing having been filed. On August 12, 2015, the Department issued the following decisions: decision # 114826, which concluded that claimant was overpaid \$112 in benefits, based on decision # 111254, and decision # 114959, which concluded that claimant was overpaid \$465 in benefits, based on decision # 105335. On August 17, 2015, claimant filed untimely hearing requests on decisions # 105335 and # 111254, and timely hearing requests on decisions # 114959 and 114826. On October 27, 2015, ALJ Monroe conducted hearings on claimant's requests for hearing, and on November 4, 2015 issued the following hearing decisions: Hearing Decision 15-UI-47122, which dismissed claimant's request for hearing on decision # 105335 as untimely; Hearing Decision 15-UI-47127, which dismissed claimant's request for hearing on decision # 111254 as untimely; Hearing Decision 15-UI-47129, which affirmed decision # 114959; and Hearing Decision 15-UI-47079, which affirmed decision # 114826. On November 24, 2015, claimant filed applications for review with the Employment Appeals Board (EAB) on all four hearing decisions.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-47122, 15-UI-47127, 15-UI-47129 and 15-UI-47079. For case-tracking purposes, this decision is being issued in quadruplicate. (EAB Decisions 2015-EAB-1405, 2015-EAB-1406, 2015-EAB-1407 and 2015-EAB-1408).

EAB considered claimant's argument to the extent it was relevant and based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 15-UI-47122, 15-UI-47127, 15-UI-47129 and 15-UI-47079 are affirmed.
