<p><b>EMPLOYMENT APPEALS BOARD DECISION</b> <b>2015-EAB-1522</b></p>
--

*Affirmed*  
*Late Requests for Hearing Dismissed*  
*Overpayment*

**PROCEDURAL HISTORY:** On July 15, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from May 17, 2015 to June 27, 2015 (decision # 95429). On July 27, 2015, the Department served notice of an administrative decision concluding claimant did not actively seek work from June 28, 2015 to July 11, 2015 (decision # 95351). On August 4, 2015, decision # 95429 became final without claimant having filed a request for hearing. On August 17, 2015, decision # 95351 became final without claimant having filed a request for hearing. On August 28, 2015, the Department served notice of an administrative decision based on decisions # 95429 and 95351 concluding claimant had been overpaid by \$3,294 (decision # 131824). On September 2, 2015, claimant filed requests for hearing on all three decisions. Claimant's requests were late with regard to decisions # 95429 and 95351, and timely with regard to decision # 131824. On December 14, 2015, ALJ M. Davis conducted a consolidated hearing, and on December 17, 2015 issued Hearing Decisions 15-UI-49535 and 15-UI-49536, dismissing claimant's late requests for hearing, and 15-UI-49541, affirming the Department's decision that claimant was overpaid \$3,294. On December 23, 2015, claimant filed applications for review of all three decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 15-UI-49535, 15-UI-49536 and 15-UI-49541. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2015-EAB-1521, 2015-EAB-1522 and 2015-EAB-1523).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 15-UI-49535, 15-UI-49536 and 15-UI-49541 are affirmed.
