PROCEDURAL HISTORY: On May 23, 2014, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 80522) concluding claimant did not actively seek work during weeks between April 21, 2013 and November 9, 2013. On June 12, 2014, decision # 80522 became final without a request for hearing having been filed. On August 27, 2014, the Department served notice of an administrative decision (decision # 140552) assessing a \$3,930 overpayment based on decision # 80522. On September 16, 2014, decision # 140552 became final without a request for hearing having been filed. On October 21, 2014, claimant filed untimely requests for hearing on both decisions.

On October 28, 2014, ALJ Kangas issued Hearing Decisions 14-UI-27734 and 14-UI-27717, dismissing claimant's requests for hearing as untimely, subject to claimant's "right to renew" the requests by submitting responses to the "Appellant Questionnaire" attached to the hearing decision within 14 days of the date the decisions were mailed. On November 6, 2014, the Office of Administrative Hearings (OAH) received claimant's response. On November 26, 2014, OAH issued two notices, "Cancellation of Hearing Decision" for Hearing Decisions 14-UI-27734 and 14-UI-27717. On December 17, 2014, ALJ Frank conducted two hearings, and on December 19, 2014 issued two Hearing Decisions. Hearing Decision 14-UI-30711 affirmed the Department's decision # 80522, finding claimant was ineligible for benefits for the periods April 21 through June 1, 2013 (weeks 17-13 through 22-13), June 16 through June 29, 2013 (weeks 25-13 and 26-13), July 7 through July 27, 2013 (weeks 28-13 through 30-13), and August 4 through November 9, 2013 (weeks 32-13 through 45-13). Hearing Decision 14-UI-30719 redismissed claimant's request for hearing and left the Department's overpayment decision # 140552 undisturbed. On January 6, 2015, claimant filed an application for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 14-UI-30711 and 14-UI-30719. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2015-EAB-1634 and 2015-EAB-1635).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 14-UI-30711 and 14-UI-30719 are affirmed.
