Overpayment, No Penalties

PROCEDURAL HISTORY: On September 14, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 84534) concluding that claimant was not available for work from May 24 through June 27, 2015 and July 5 through July 11, 2015 (weeks 21-15 through 25-15 and 27-15). Claimant filed a timely request for hearing on decision # 84534. On October 15, 2015, the Department issued a decision concluding that, based on decision # 84534, claimant was overpaid benefits in the amount of \$566, and assessing a \$141.50 monetary penalty and six penalty weeks (decision # 195540). On October 16, 2015, ALJ Shoemake conducted a hearing on claimant's request for hearing on decision # 84534, the decision concerning claimant's availability for work, and on October 22, 2015, issued Hearing Decision 15-UI-46394, affirming decision # 84534. On November 12, 2015, Hearing Decision 15-UI-46394 became final without an application for review having been filed.

On January 27, 2016, ALJ Triana conducted a hearing on claimant's request for hearing on decision # 195540, the overpayment decision and on January 29, 2016, issued Hearing Decision 16-UI-52015, modifying decision # 195540. In Hearing Decision 16-UI-52015, the ALJ concluded that claimant was overpaid benefits in the amount of \$566, but assessed no monetary penalty or penalty weeks. On February 16, 2016, claimant filed an application for review of Hearing Decision 16-UI-52015.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), Hearing Decision 16-UI-52015 is **adopted**.

DECISION: Hearing Decision 16-UI-52015 is affirmed.
